(37 of 1970) is published as required by sub-section (1) of section 35 of the said Act, for information of all persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration by the Government of Gujarat on or after the expiry of thirty days from the publication of this notification in the *Official Gazette*.

2. Any objection or suggestion which may be received by the Additional Chief Secretary to the Government of Gujarat, Labour and Employment Department, Sachivalaya, Gandhinagar from any person with respect to the said draft rules on or before the expiry of the aforesaid period will be considered by the Government.

No : GHR/2020/152/CLA/152020/415126 /M (3):- In exercise of the powers conferred by section 35 of the Contract Labour (Regulation and Abolition) Act, 1970. (37 of 1970). The Government of Gujarat hereby makes the following rules further to amend the Contract Labour (Regulation and Abolition) (Gujarat) Rules, 1972, namely:-

1. (1) These rules may be called the Contract Labour (Regulation and Abolition) (Gujarat) (Amendment) Rules, 2020.  
(2) They shall come into force on the date of their publication in the *Official Gazette*.
2. In the Contract Labour (Regulation and Abolition) (Gujarat) Rules, 1972 (hereinafter referred to as the said rules), in rule 24, for the figure "Rs. 270" the figure "Rs. 540" shall be substituted.
3. In the said rules, for rule 26, the following rule shall be substituted namely:  
"26. Fees: - (1) The fees to be paid for the grant of certificate of registration under section 7 shall be as specified below, namely:-

If the number of workmen proposed to be employed on contract on any day,-
